

Can solar container lithium battery packs be checked in



Overview

You cannot bring lithium metal and lithium ion batteries, including external battery packs, in checked baggage. Always check your airline's baggage policies for the latest regulations. Lithium batteries need to be shipped with care to avoid issues like delays or rejected cargo. Due to their potential fire risk, they are considered dangerous goods and must follow international rules for packaging, labelling, documentation, and approvals. This guide provides scenario-based situations that outline the applicable requirements that a shipper. Lithium batteries can be carried by air depending on configuration and Watt-hour rating (for rechargeable) or lithium content (for non-rechargeable). For. This document is based on the provisions set out in the 2025-2026 Edition of the ICAO Technical Instructions for the Safe Transport of Dangerous Goods by Air (Technical Instructions) and the 67th Edition (2026) of the IATA Dangerous Goods Regulations (DGR).

Dangerous items

We allow avalanche packs that have a lithium battery under 100WH as checked or carry-on bags. If you're checking an avalanche pack, you must remove the battery. An agent will inspect and approve

Restricted items – Travel information – American Airlines

Since some devices use lithium ion batteries, you cannot travel with them in your checked bags. You can travel with them in your carry-on, but you're not allowed to use them on board any flight.
